# Foreign Tourist Arrivals To India Before And After Pandemic

#### Abstract:

Tourism industry is growing as one of India's largest service sector. It is one of the major sectors of Indian economy which contribute a major proportion of the National income and provides huge direct and indirect employment opportunities. India is having rich cultural and historical heritage. It has visitor friendly traditions which attract millions of tourists, wildlife lovers, beach lovers, adventure seekers, festival lovers across the globe each year. Tourism industry fetches foreign exchange to India. The main objective of this paper is to study number of Foreign Tourist Arrivals in India, major source countries for FTAs in India, their purpose for visits, visits to states or union territories by foreign tourists and foreign exchange earnings from tourism in India and effect of pandemic on number of FTAs and Foreign Exchange Earnings. For this paper secondary data regarding foreign tourist arrivals is collected from India Tourism Statistics 2022. This paper makes an attempt to provide an in-depth analysis about foreign tourist arrivals in India.

### **Introduction:**

Tourism is one of the largest and fast growing service sectors in India and India is large market for travel and tourism. It plays an important role in the growth and development of Indian economy. In 2021, the travel and tourism sector in India contributed around 5.8 percent to the total GDP of the country this amounted to over 13 billion Indian rupees.

There are variety of forms of tourism in India which includes eco tourism, beach tourism, wildlife tourism, cultural tourism, adventure tourism, religious tourism, sports tourism, business tourism etc. Tourism industry boosts

Indian economy through earning foreign exchange and creating employment opportunities to the people. This sector provides direct and indirect employment opportunities to large population in the country. The travel and tourism sector in India provided employment to nearly 80 million people in 2020.

India ranked 54<sup>th</sup> according to the Travel and Tourism Development Index, 2021. This ranking was allotted considering the industry's environment, policies, infrastructure, demand drivers and sustainability.

COVID-19 pandemic has hampered the trend of Foreign Tourist

Arrivals to India for 2020 and 2021. Though there were some restrictions in tourism sector to contain the spread of virus during this pandemic, India had 7.00 million International Tourist Arrivals in 2021.

# **Objectives of the Study:**

- 1. To study purpose of Foreign Tourist Arrivals in India.
- 2. To know major source countries for FTAs in India.
- 3. To know about Foreign Tourist Visits to different states and union territories in India.
- 4. To study effect of pandemic on foreign tourists arrival in India.

### **Limitations of the Study:**

The study considers only foreign tourist arrivals in India. Domestic Tourists are not considered for the study.

### **Methodology of the Study:**

The present study deals with study of Foreign Tourist Arrivals in India. Present study is based on secondary data compiled from various books, references and official websites of Government of India.

The data regarding number of FTAs, NRIs and ITAs was collected. The data related to purpose of FTAs was

compiled. The figures related to Foreign Exchange Earnings by India were collected. The data related to top states and Union Territorries to which foreign tourist were visited is collected for the year 2021. The data regarding Foreign Exchange Earnings from Tourism in India was also collected.

### **Data Analysis and Interpretation:**

Tourism is one of largest service sector in India. Along with tourism other industries such as agriculture, horticulture, handicrafts, construction, hospitality, hotel also grow. India is one of the large market for foreign tourists. Group of Monumnet, Mamallapurum, Taj Mahal, Tiger headed Rock cut temple, Sluvankuppam, Agra Fort, Gingee Fort, Vattakottai Fort, Red Fort, Outub Minar, Fort Museum, Thirumayam, Rock Cut Jain Temple, Sittanasal etc are the popular centrally protected monuments which Foreign tourists. Secondary data regarding Foreign Tourist Arrivals in India, Nonresident Indians and International Tourist Arrivals in India, Purpose-wise Foreign Tourist Arrivals in India, Top 10 Source Countries for FTAs in India, Foreign Tourist Visits to different states and union territories and Foreign Exchange Earnings from Tourism in India is presented in following tables

From the above table 1 it is clear that there is continuous increase in Foreign Tourist Arrivals in India from 1981 to 2019. But in 2020 due to pandemic across the world and the lockdown in India Foreign Tourist Arrivals has shown a

negative growth of 74.9% and 44.5% in 2020 and 2021 respectively.

Since 2014, Government of India has started to collect data of arrivals of Non Returning Indians and International tourist arrivals.

From the above table 2 it is clear that there was continuous increase in NRIs arrivals in India from 2014 to 2021. After pandemic again NRI arrivals have registered 52.6% growth in 2021 over 2020.

In the case of Foreign Tourist Arrivals also there was continuous increase from 2014 to 2020. But in 2020, due to CIVID-19 FTAs arrivals have registered negative growth in 2020 over 2019.

From the table no. 3 it is evident that in 2019 majority (57.1%) of FTAs were for leisure holiday and recreation, followed by business and professional purpose (14.7%), Indian Diaspora (12.7%), other purposes (9.2%) and only 6.4% FTAs were visited to India for medical purpose.

In 2020 also, majority (57.1%) of FTAs were visited India for leisure holiday and recreation purpose, followed by Indian Diaspora (13.9%), business and

professional purpose (11.7%), other purposes (9.5%) and only 6.7% FTAs were visited to India for medical purpose.

In the case of 2021, majority of FTAs were arrived in India for Indian Diaspora purpose, followed by other purpose (21.9%), the percentage of FTAs arriving to India for medical purpose was increased to 19.9 in 2021.

It shows that the preference to purpose of FTAs in India changes year to year.

Table no. 4 shows the majority (28.1%) of the FTAs were from USA, followed by Bangladesh (15.8%), UK (10.7%), Canada (5.3%), Nepal (3.4%),

Afghanistan (2.4%), Australia (2.2%), Germany (2.2%), Portugal (2.1 %) and France (2.0%). The share of FTAs from top 10 countries was 74.2% during 2021.

tourism sector across the world along with India. The reason for decline in the foreign tourist visits in the years 2020 and 2021 was the pandemic situation and continuous lockdown in India.

Table no. 6 depicts that in the year 2021 Punjab was the favorite state for the foreign tourists. Other states in foreign tourist visits in 2021 were Maharashtra (17.60%) followed by Delhi (9.50%), Karnataka (6.87%), Kerala bags 5<sup>th</sup>

position with 5.74% followed by Tamil Nadu (5.46%), Uttar Pradesh (4.24%), Madhya Pradesh (3.94%), West Bengal (3.30%), Rajasthan (3.30%). These top ten states and UTs accounted for about 89.17 of the total foreign tourist visits.

There is ups and downs in the foreign exchange earnings from 2011 to 2021. Foreign exchange earnings from tourism in India in 2021 is Rs. 65070 crores as compared to Rs. 50136 crore in 2020 which shows a growth of 29.8% in 2021 over 2020.

# **Findings:**

- 1. There is continuous increase in FTAs in India from 1981 to 2019. But due to COVID-19 FTAs showed negative growth rate of 74.9% and 44.5% in the year 2020 and 2021 respectively.
- 2. In 2021, majority of FTAs were arrived in India for Indian Diaspora purpose.
- 3. United Stats of America has been the largest among the tourist generating markets for India in 2021.
- 4. There has been continuous increase in foreign tourist visits in India, except the years 2001, 2020 and 2021.
- 5. Punjab was the favorite state for the foreign tourists in 2021.
- 6. There are ups and downs in the foreign exchange earnings from 2011 to 2021. COVID-19 pandemic led to loss of foreign exchange earnings. Foreign exchange earnings from tourism in India shown negative growth rate of 76.3% 2020 over 2019.

### **Conclusion:**

Tourism is one of the fastest growing service sectors in India. It works as growth engine of Indian economy by contributing handsome towards GDP and

and providing direct indirect by employment opportunities to number of people. Due to foreign and domestic visitors there is growth of hotel industry, hospitals, aviation and shipping sector, travel agents, restaurants, shops in the country. There is remarkable growth in International Tourist Arrivals in India except in pandemic period. Continuous efforts made by the Ministry of Tourism are one of the important reasons behind the increase in FTAs in India. In Indian Travel and Tourism industry will be distinguished by exciting growth, innovation technological and transformation.
