Vegetables-

Maharashtra is the leading producers of onion in India. Though Maharashtra is a leading producer of agricultural, horticultural and marine products. It is poor as for as their processing is concerned. As per estimates, the sates overall processing rate excluding those of dairy and food grains is about 7%. It certainly can increase its value addition to 25% over the next ten years with proper focus and implementation policies.

For the last 41 years, Maharashtra has been a leader in food processing, owing to many advantages such as political stability, Friendly government policies (Particularly from MOFPI), good work in basic agricultural research and hybridization, forward – thinking farmers and good production supply, a good industry base; closeness to the market careful of growing urbanization) and high export potential.

Challenges faced by food processing industry in Maharashtra in modern era-

1) Unorganized Players-

The largest challenge faced by the food processing sector is that it is dominated by unorganized players, who contribute to 82% of the industry's volume there is a conversion of unorganized players to organized ones, but a fair distance still needs to be crossed.

2) Unavailability of a Process able Quality and Quantity-

This is second challenge the unavailability of a process able quality and quantity of fruit and vegetables; the low productivity of agro based products; the small and holding of formers, the poor processing conversion.

- 3) High Degree of reasonability
- 4) Gaps in supply chain infrastructure-Food processing sector are gaps in supply chain infrastructure which is inadequate primary processing.
- 5) Insufficient connection between production and processing-The insufficient connection between production and processing; seasonality of operations and low capacity utilizations institutional gaps in the supply chain, for example there is a dependence on APMC markets.
- 6) Fluctuations in the availability of raw materials and their prices.
