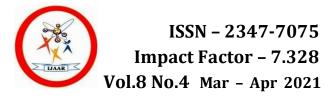

The post-colonial period witnessed challenges such as ethnic identity movements, language politics, economic marginalization, and the quest for cultural assertion. These contexts shaped a literary landscape in which Assamese writers began to explore issues of identity, nationalism, migration, regionalism, alienation, ecological consciousness, linguistic struggles, gender marginality, and socio-political crises. Thus, post-colonial Assamese literature is not only a body of creative works—it is a socio-historical testimony and a cultural text reflecting the struggles, dreams, and transformations of Assamese society.
