Social Capital means a mutual understanding among the existing members of a civil society. Civic traditions and stock of social capital are necessary ingredients for blooming democracy, building resilience and sustainable development. On the other hand, local governance means a continuous flow of administration, where state itself transferred its power and energy to the grassroots level democratic institutions. It is needless to mention that democracy, decentralization and collective decisions are the three basic components of sustainable development.

N-E India is the highest literacy zone in India and the richest ecosystem in the world. The region is famous for outstanding bio-diversity along with an endangered threatened species. The region touches the border of Bangladesh, China, Myanmar, Nepal, Bhutan. So, the political significance of the region is gradually developing.

N-E India is one of the best governed Zone in South-East Asian politics even some unexpected experiences in Manipur. In N-E India, democratic institutions in grassroots level are more functional rather than other parts of the Indian sub-continent and even in the South - East Asian politics.

Therefore, the issue of collective actions and role of local governance regarding the issue of environmental justice and sustainable development are somewhat distinct in this context. However, no systematic studies of performance of local governance and its impact on preservation of bio-diversity and sustainable development are being observed. This is the significance of the present research work.
