The mermaids symbolize beauty, fantasy, and unattainable desire. Prufrock's exclusion from their world reflects his feelings of inadequacy and alienation.

Use of Imagery and Irony:

Eliot's imagery is vivid, unconventional, and deeply symbolic. The poem contains images of dirty streets, smoky air, lonely rooms, and restless nights, all contributing to the atmosphere of urban decay.

Irony is another important element. The title itself is ironic because the poem lacks the passion and harmony usually associated with love songs. Similarly, Prufrock imagines himself as a tragic figure, yet he admits:

“No! I am not Prince Hamlet.”
